## Treasurers Report – Vic Culp

- Corrections from report
  - o Have received financials from Great Falls, Wheaton and Mason Neck
  - Vic checked with IRS and we only have to hold our records for three years after the filing date (essentially 4 years) unless we've fraudulently filed
  - Vic made a deposit in 2016 for a number of meets that happened in 2015. Vic proposes to move that transaction to 2015 calculations.
  - Vic plans to throw out financial records from meets prior to 2011, will take them to a shredder (fee-for-service)
- Questions for report
  - OUSA is looking into offering assets insurance for clubs is this something that maybe worthwhile
    - Is the policy item specific or a blanket number? Rate probably based on a certain amount per every \$1000 in assets.
    - Don't know what the premium is yet
    - \$50,000 is usually the minimum rate for this type of insurance, OUSA can combine it, so we wouldn't need to insure that much
    - Greg will find out how much the insurance rate will be and report back

## Maryland VP Report - Tom Nolan

- Tom gave his report
- Some complaints on McKeldin courses were received. Should we assign a course consultant to each course setter, especially newer ones? Sounds like a good idea.
  - Suggest having a small cadre of "couch" course consultants to review courses (suggestions: Don Davis, and Daniel)
- Six more meets in Maryland for this season
  - o Little Bennett if there is still snow, they will not be plowing the parking lots
  - Three events are missing meet directors still, Tom doesn't anticipate having trouble recruiting them
  - Moved Jug Bay due to conflicts with a DVOA rogaine at PEEK
  - None of these events will require pre-registration. The Chase is pre-reg, but it's a free event for members, so that's an easy one.
  - Membership database could offer opportunities for carpooling since people can look up who lives near them to find rides.
    - Should encourage people to carpool for Little Bennet
  - Greg/Kathleen setting up on each event page a "volunteer" button that will send a message to the event director
    - Will also be sending an additional message in the new member packet about how the club, being all volunteer relies on all members volunteering
    - Can also set up a proximity search for each venue for voluteers

# Publicity - Greg and Kathleen Lennon

- All social media sides are growing at a steady rate
- The latest round of calendar cards will not be able to sent out. Due to unpredictability of weather they won't be
- Membership portal fully functional: member.qocweb.org
  - No longer taking memberships at meets remind meet directors
  - No free for first time orienteers anymore
- Memberships as of Feb 1, 2016:
  - o 195 Individual
  - o 157 Family members (individual)
  - o 4 Junior groups some are not going to be renewing due to no economic advantage
- Some event directors have now switched to a cell phone number rather than license plate
  - o Concerns about no longer collecting car information
- Greg audited the number the people who said they were active members against actual active memberships and only two out of 104 weren't actual active memberships
  - o Real-time membership check may not be necessary
- New member letter will have a lot more info about social media, and Kathleen is testing mailing Buffs to renewed QOC members
